

RESOLUTION 2025 - _____

A RESOLUTION OF THE CITY COUNCIL OF SUNNYSIDE, WASHINGTON, DECLARING CERTAIN VEHICLES SURPLUS AND AUTHORIZING DISPOSITION, AND AUTHORIZING THE PURCHASE OF TWO FULLY EQUIPPED POLICE VEHICLES THROUGH THE STATEWIDE VENDOR CONTRACTS FOR POLICE VEHICLES.

WHEREAS, the City of Sunnyside has two police vehicles that have been declared totaled by the City's insurance provider, Washington Cities Insurance Authority,

WHEREAS, the patrol vehicles for surplus are:

- (1) #536: 2017 Ford Explorer, License plate # 60786D, VIN 1FM5K8AR2HGA24634
- (2) #539: 017 Ford Explorer, License plate # 64068D, VIN 1FM5K8AR8HGD13680, and

WHEREAS, the police vehicles were insured and the city will be reimbursed for the costs of purchasing and outfitting each of the two new police vehicles, and

WHEREAS, there are currently two 2024 Ford Police vehicles available for immediate purchase through the Statewide Vendor Contracts List for police vehicles, and

NOW THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYSIDE, WASHINGTON:

SECTION 1. Vehicle #536: 2017 Ford Explorer, License plate # 60786D, VIN 1FM5K8AR2HGA24634 and Vehicle #539: 017 Ford Explorer, License plate # 64068D, VIN 1FM5K8AR8HGD13680, are declared surplus.

SECTION 2. Acquisition of two new police vehicles through the Statewide Vendor Contracts List for Police Vehicles is approved.

SECTION 3. The City Manager is hereby authorized to execute and administer all documents and contracts necessary or appropriate to accomplish the acquisition of the new vehicles; and to dispose of vehicles #536 and \$539 declared as surplus in accordance with applicable procedures and law.

SECTION 4. The City Clerk is authorized to make the correction of scrivener's/clerical errors, references, Resolution numbering, section/subsection numbering and any references thereto.

SECTION 5. Effective Date. This Resolution shall be effective upon passage, approval and signatures heron in accordance with law.
