A RESOLUTION OF THE CITY COUNCIL OF SUNNYSIDE, WASHINGTON, AUTHORIZING THE CITY OF SUNNYSIDE TO SPONSOR THE SPIRIT OF SUNNYSIDE AWARDS DINNER AND AUCTION, INCLUDING THE PROVISION OF FACILITY USE, PURCHASE OF AWARDS, AND AUTHORIZATION FOR STAFF INSTALLATION AND REMOVAL OF EVENT EQUIPMENT.

WHEREAS, the City of Sunnyside recognizes the importance of fostering community engagement and celebrating the exceptional contributions of its residents; and

WHEREAS, the Miss Sunnyside Committee has organized the Spirit of Sunnyside Awards Dinner and Auction, an event designed to raise funds for the Miss Sunnyside Scholarship Program while honoring individuals within the community who exemplify outstanding dedication and service to the city; and

WHEREAS, the Spirit of Sunnyside Awards Dinner and Auction serves as a significant opportunity to celebrate the achievements of the city's most exemplary individuals, while promoting community involvement and supporting educational opportunities for local youth; and

WHEREAS, the City of Sunnyside wishes to support the Miss Sunnyside Committee in the successful execution of this important event through the provision of appropriate resources and logistical assistance; and

WHEREAS, the City Council has determined that the sponsorship of the Spirit of Sunnyside Awards Dinner and Auction is in the best interest of the community, reinforcing civic pride and the recognition of local leaders.

**NOW THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE
CITY OF SUNNYSIDE, WASHINGTON:**

SECTION 1. The City of Sunnyside hereby authorizes its sponsorship of the Spirit of Sunnyside Awards Dinner and Auction to be held on April 26, 2025.

SECTION 2. The City of Sunnyside grants the Miss Sunnyside Committee use of the Sunnyside Community Center at no charge, including the gymnasium for the event, on the specified date of April 26, 2025.

SECTION 3. The City of Sunnyside shall allocate funds for the purchase of awards and recognition items to honor the distinguished community members to be celebrated at the event.

SECTION 4. The City of Sunnyside shall authorize the use of city staff or contracted services for the installation, setup, and subsequent removal of event-related equipment, tables, and drapes within the Sunnyside Community Center gymnasium, as necessary to support the event.

SECTION 5. The City Clerk is authorized to make the correction of scrivener's/clerical errors, references, Resolution numbering, section/subsection numbering and any references thereto.

SECTION 6. Effective Date. This Resolution shall be effective upon passage, approval and signatures hereon in accordance with law.
